

Proud to be you

"We're Kappa Proud" — what a fitting theme for the 57th Biennial Convention, a convention that just felt good all over — from the first arrival through the last departure.

Fraternity council and convention committee members, who had been planning this convention for the past two years, began coming to the Boca Raton Hotel and Club as early as June 16 to prepare for the arrival of the majority of convention-goers on June 21. Everyone quickly settled into the beauty of this convention site with its old-time charm coupled with modern-day living and meeting conveniences. In her welcome to Boca Raton at the orientation session, Rebecca Roper Matkov, \Darks B-Duke, founding editor of Preservation Today magazine and co-author of Florida's Historic Restaurants, presented an historical perspective of the Boca Raton Hotel and Club and its surrounding attractions. Her picture of the site as presented through her description in the Fall 1987 issue of The Key really came to life for those actually in the glory of its ambiance. Her welcome added to the reception which had been afforded all arrivals at the Ft. Lauderdale airport by the gracious area alumnae. Kappas come every two years from far and wide to make new friends, renew longtime friendships, feel pride in past accomplishments, become further educated about Kappa and challenges to the Fraternity, conduct Fraternity business and elect officers for the biennium.

By the time the sound of the gavel officially opening convention was heard, close to 800 Kappas had arrived and had already immersed themselves in the camaraderie, ceremony and concerns of convention. At the opening session, four new chapters were seated, and one new alumnae association and six new clubs were welcomed.

Kappa pride surfaced with the parade of chapter flags at dinner the first night. It continued to swell as President **Marian Klingbeil Williams**, Θ -Missouri, delivered the opening address and distributed the printed biennial report. Flanked by the flags of each of the 117 chapters, she challenged Kappas everywhere to preserve human dignity, selfworth and respect — so vital in our lives.

Departing from the usual report of statistics and progress information, she emphasized that we should "be all we say we are" and tell the Kappa story accurately and effectively. She pointed out the need for individual responsibility in the attempt to rise above issues confronting all of society: "You may not have control over the actions of others, but you can control your own." Those present were indeed ready to accept the challenge and absorb all that convention had to offer when she concluded that, "It's not what we get out of Kappa Kappa Gamma that makes us Kappa proud, it's what we become because of the influence she has been in our lives."

The charge to preserve the ideals of our founders, which have withstood the tests of time, was further emphasized through the report of the long range planning committee. This included studies during the past biennium on the structure of the convention committee, the philanthropy focus, the structure of the Heritage Museum Board of Trustees, council tenure, initiation of college alumnae and the convention vote.

It was with these challenges that the convention body began a series of workshops, which offered programming


ideas and training skills, geared to both active chapter and alumna life. There were also specialty workshops involving legal situations, preserving safety and security of Kappa facilities, AIDS and Panhellenic. Ritual workshops presented complete model initiations. "Speak-up" conversations with the director of chapters encouraged discussion of special concerns, and "interacts" with the winners of both chapter and alumna awards allowed the sharing of what makes up an award-winning group.

Individual achievement is recognized by the Alumnae Achievement Awards, which continue to be an eagerly awaited highlight at every convention. The award winners appeared in a panel and also led workshops in such topics as "International Trade," "Making the Most of Your Talents," "Suicide Among College Students: Implications for Prevention," and "Leading Three Lives at Once." Each Achievement Award recipient credited her Kappa experiences for some part of her success and challenged each Kappa

to set goals and go forward to achieve anything she wants. During the alumnae award presentations came the announcement of the 1988 Loyalty Award winner — a person whose name is synonymous with the service and dedication for which the award is made — **Jean Hess Wells,** ΔY -Georgia. Her 1976-80 terms as Fraternity President are just one part of her life of Kappa service. Currently Fraternity ritualist, she continues her support of the basic beliefs of Kappa and loyalty to her ideals, which makes her the true image of what the Loyalty Award represents.

Loyalty, service, dedication — that's what it's all about — that's what gains us the pride which was so evident at this 57th Biennial Convention. But with the pride comes the caution that "Pride goeth before the fall," according to **Phyllis Brinton Pryor,** BM-Colorado, in her candlelight banquet speech. As National Panhellenic Conference delegate, she is well aware of the challenges to be faced in the next decade, which she so carefully clarified. With the privilege of being "Kappa Proud" goes the responsibility to continue and to strengthen those qualities and ideals upon which that pride is based. She summed it up by saying, "Ten little two letter words say it all — If it is to be, it is up to me!"

This is the challenge that each took home. And along with that challenge went all the printed programs, the three issues of *The Hoot*, lots of film to be developed, boutique and Kappa Kollection purchases, addresses of new friends, notes and notes of ideas and solutions, many memories, and a certain frustration . . . a frustration of how to convey to those Kappas back home all the convention feelings . . . feelings of security that Kappa is forever and everywhere, which is so clearly evident when over 800 women gather in a meeting and repeat the same ritual and attest to the common bonds . . . feelings of security that Kappa is in good hands with a newly elected, committed Fraternity council . . . feelings of support in the ideas gleaned from workshops, from talks, from getting better acquainted with others in the same province . . . feelings of challenge from the words of Marian Williams, Phyllis Pryor and others and with the introduction of the Adelphe Campaign . . . feelings of pride - pride in being you and me in KKG!!

The 'first' constitution of Kappa Kappa Gamma

So much of the early years of Kappa Kappa Gamma remains veiled in mystery. All records of Alpha Chapter-Monmouth have been lost to posterity, and even the first historians of the Fraternity dispaired over the obstacles involved in establishing accurately the history of the first 12 years. Efforts to reconstruct the first years of Kappa Kappa Gamma began as early as 1882 when the Convention featured as "literary entertainment" the "history" and the presenter was Minnie Stewart Nelson, A-Monmouth, one of the founders. Not even she was able to "procure the necessary information." Despite the difficulties, early historians preserved, and they undertook with painstaking care the task of restoring records, including correspondence with the founders and living members of Alpha and other early chapters. When the files were shipped to a new historian in 1907, an express car fire destroyed one of the two boxes and lost was most of the correspondence and all the "letter books" of the Grand Council officers. Fortunately, Delta Chapter-Indiana, established by Alpha in 1872 and Kappa's oldest living chapter, was meticulous in its record-keeping. The Delta Red Book, on display at Fraternity Headquarters, is the oldest known document of the early years of Kappa Kappa Gamma, and it is our

most treasured historical resource.

When the Monmouth College administration banned fraternities, Alpha Chapter passed the responsibility of Grand Chapter to Delta Chapter and Delta served in this capacity from 1875 to 1878. Undoubtedly, early historians worked with Delta Chapter in their efforts to establish the early history of the Fraternity. In the Delta archives are several fascinating documents, all witnessed as being "duplicates of the Original Records in the hands of the Fraternity historian" and dated January 14, 1904, when Minnie Royse-Walker, I-DePauw, was the historian and just after she had written the oldest extant history of the Fraternity: Kappa's Record, 1903. In the copy of the "Records of Grand Secretary of Kappa Kappa Gamma, Law of the Fraternity" is the "Constitution of 1870," as well as one for 1875 and another as approved by the 1876 Convention.

In honoring Founders' Day, Kappas everywhere recall those early members of Alpha Chapter-Monmouth and how remarkable indeed was their vision of a Greek-letter society for women. However, we rarely recognize that their dream included the very basic tenents of administration, and some of their ideas remain standard practice today. Below is the first publication of our earliest known constitution, attributed to Alpha Chapter.

While the historian believes that this is not the first constitution drawn up by Alpha Chapter, she does believe that it is the earliest Kappa Constitution in existence and that it was drawn up by Alpha around 1872 when Alpha was Grand Chapter. In the very beginning, Alpha Chapter was strictly Kappa Kappa Gamma Fraternity; not until extension began in 1871 did the Monmouth group become Alpha Chapter. In the files is a copy of the Constitution and Bylaws for the Monmouth literary society, Amateur des Belles Lettres, which was founded in 1857 and to which four of the founders belonged when they founded Kappa Kappa Gamma; on the committee of six named to revise the bylaws of this literary society in 1874 were three members of Alpha Chapter; the resemblances between the Constitution and Bylaws of Amateur des Belles Lettres and the so-called 1870 Constitution of KKG are striking in wording and ordering.

Preamble:

We, believing that a closer union in the bonds of friendship would be for our mutual benefit, do hereby unite ourselves into a fraternity to be called K.K.G., and do hereby pledge ourselves to be governed by the following constitution and By-Laws:

Article I. Name and Object.

Sec. 1. Name shall be — — — Sec. 2. Object of this fraternity shall be the strengthening of friendship and the advancement of its members socially and in literary attainments.

Sec. 3. Motto shall be -

Article II. Officers

Sec. 1. Officers of Fraternity shall consist of President, Scribe, and Treasurer.

Article III. Duties of Officers.

Sec. 1. The duty of President shall be to preside at all meetings; to announce meetings; call or adjourn meetings; to impose fines or taxes; to criticize performances; to initiate new members; to install new corps of officers; to call for excuses for absences; and to deliver a valedictory on retiring from office. President shall always have a vote.

Sec. 2. The duty of Scribe shall be to call the roll; to carry on correspondence with other chapters; read minutes of previous meetings; call on performers; and, in the absence of President,

Sec. 3. The duties of Treasurer shall be to take charge of all money belonging to the Fraternity; to procure badges and to give a written report of all money passed through her hands during her term of office; and in other respects her duties shall be similar to those of Treasurer in any other corporation.

Sec. 1. Officers shall be elected at the close of every term. Election shall be by acclamation.

Article V. Installation of Officers

Sec. I. Officers on being installed shall answer to the following oath: Do you promise on the honor of ladies to adhere to the Constitution and to faithfully perform the duties incumbent upon you in your respective offices?

Article VI. Amendments.

Article VI. Amendments.

Sec. I. Any chapter proposing an amendment to this Constitution shall pass it unanimously in their own chapter and forward
it to the Alpha Chapter. If the Alpha Chapter pass it unanimously
they shall forward it to the other chapters; if they pass it, it shall be appended to the Constitution.

By-Laws.

Article I.

rticle I. Time of Meeting. Sec. 1. This shall be at the option of each chapter, but shall be at least once in two weeks.

Article II. Quorum.

Sec. 1. A quorum shall consist of three members.

Article III. Candidates. Sec. 1. Any lady may become a candidate for membership who shall be of good moral character, and of above average talent; and who, at the time of proposal, either is or has been in atten-dance at some College or Seminary.

Article IV. Voting.

Sec. 1. Names proposed for membership shall be voted on by ballot

Article V. Initiation.

Sec. 1. Members-elect at the next regular meeting initiated by following oath, placing right hand on the Bible: Do you solemnly swear to adhere to the Constitution; not to divulge any secrets of the Fraternity, and to exert your influence for its welfare?

Sec. 2. Any person or persons at a distance may be initiated by signing and returning the oath of initiation.

Article VI. Dismissals.

Sec. I. Any person desiring an honorable dismissal from K.K.G. shall state her reasons before her chapter, and upon their unanimous acceptance, the President shall grant her a Dismissal.

Sec. 2. Any person who by violation of the Constitution or by conducting herself so as to injure the good name of the Fraternity, shall render herself obnoxious to her chapter, may be expelled by a majority vote.

Article VII. Forfeits.

Sec. 1. Any person dismissed honorably or otherwise shall forfeit

her pin to the Fraternity.

Sec. 2. No member shall lend her pin to anyone outside the Fraternity. In violation of this she shall be subject to a fine of five dollars.

Article VIII. Voting Term.

Sec. 1. The voting term shall be ---, and shall be used at all elections and voting by acclamation.

Helping others . . . Kappa's rich tradition

Rehabilitation Services was designated in 1952 as the focus of Kappa's philanthropic service. The area of rehabilitation is a broad one encompassing work with the mentally retarded, the physically handicapped, the social deprived, the emotionally disturbed, the learning disabled and the aged. In 1988-89, 22 graduate scholarships of \$1,000 and 10 undergraduate scholarships of \$750 will be awarded to both members and non-members for study in some facet of the rehabilitation effort.

Representative of the well-qualified and most deserving women who have been recipients of Kappa's financial aid is **Elizabeth Call**, ΓΞ-California, Los Angeles, who was awarded a graduate scholarship for both 1986-87 and 198788. Libby, who now calls Denver her home, is attending the University of Denver Graduate School and will receive her doctorate in clinical psychology in 1990. In addition to her academic courses, Libby works as a counselor in the Vicitim Assistance/Death Notification Program of the Denver Police Department. This involves notifying and supporting survivors of any unattended death or deaths in which criminal conduct may be involved. Libby adds, "I am able to develop my skills in working with those who are grieving and frequently in a state of crisis. At the same time, I am happy to be providing a valuable service to my community, one that I hope will one day be provided nationwide."

The rising cost of a college education and the decreasing financial assistance available from other sources make additional scholarships and student aid absolutely vital to members of Kappa today. These scholarships take on added importance in that they offer aid to middle-income students who may not be eligible for other educational grants.
